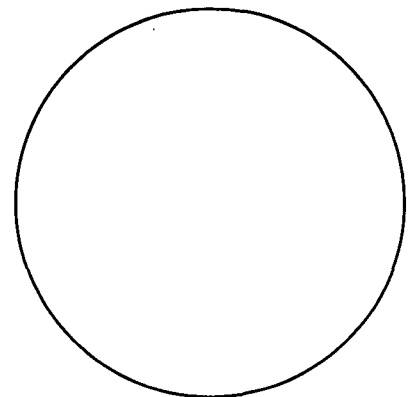

THIS IS THE LAST WILL AND TESTAMENT of me **DENNIS FURNACE BROWN** of 87 St Margaret's Avenue North Cheam Surrey **WHEREBY I REVOKE** all former wills and testamentary dispositions made by me **AND DECLARE** this to be my last Will

1. **I APPOINT ARTHUR HENRY BARRON** and **ANDREW WILLIAM SAUNDERS** both of 19/21 Central Road Worcester Park Surrey KT4 8EH solicitors to be the executors and trustees of this my Will but if either of them shall be unable or unwilling to act then I appoint the partners at the date of my death in the firm of Vivash Hunt of 19/21 Central Road Worcester Park aforesaid or the firm which at that date has succeeded to and carried on its practice to be the executors and trustees of this my Will (and I express the wish that two and only two of them shall prove my Will and act initially in its trusts) **AND I DECLARE** that in the interpretation of this my Will the expression "my trustees" shall where the context so admits) mean and include the executor and trustee or the executors and trustees for the time being hereof whether original additional or substituted
2. **I GIVE** free of all duties all my investments in CIS including bonuses and interest shares to the **IMPERIAL CANCER RESEARCH FUND** of PO Box 123 Lincoln's Inn Fields London WC2 and **MACMILLAN CANCER RELIEF** of Room 90 Anchor House 15-19 Britten Street London SW3 and **I MAKE** this bequest with much appreciation in recognition of the care bestowed on my late wife Ivy Emma Brown during her long illness
3. **I GIVE** free of all duties my freehold property known as 87 St Margaret's Avenue North Cheam Surrey together with all my furniture electrical appliances china glass and linen to **GARY and SARAH HOGAN** of 194 Green Wrythe Lane

4. **I GIVE** all my real and personal property whatsoever and wheresoever not hereby or by any codicil hereto specifically disposed of (including any property over which I may have a general power of appointment or disposition by Will) to my trustees upon trust to sell call in and convert the same into money with power to postpone such sale calling in and conversion for so long as they shall in their absolute discretion think fit without being liable for loss
5. **MY** trustees shall out of the monies to arise from the sale calling in and conversion of or forming part of my estate pay my debts funeral and testamentary expenses and all inheritance tax payable in respect of my estate and shall invest the residue of such monies in any investments of a nature hereby authorised with power from time to time to vary investments for others of an authorised nature and shall stand possessed of such investments and of all parts of my estate for the time being remaining unsold and any ready money (hereinafter called "my residuary estate") upon the trusts hereinafter declared concerning the same
6. **MY** trustees shall hold my residuary estate as to both capital and income upon trust for **STEPHEN BURNARD** of 131 Collingwood Road Sutton Surrey but if he die in my lifetime leaving issue who attain the age of 21 years or marry under that age such issue shall take by substitution and if more than one in equal shares per stirpes the share of my residuary estate which the said Stephen Burnard would have taken had he survived me but so that no issue shall take whose parent is alive and so capable of taking
7. **I DECLARE** that if before my death (or after my death but before my trustees have given effect to the gift in question) any charitable or other body to which a

gift is made in this my Will has changed its name or amalgamated with or transferred all its assets to any other body then my trustees shall give effect to the gift as if it has been made (in the first case) to the body in it changed name or (in the second case) to the body which results from such amalgamation or to which the transfer has been made

9. **THE** Standard Provisions of the Society of Trust and Estate Practitioners (1st Edition) shall apply with the deletion of Paragraph 5. Section 11 Trusts of Land and Appointment of Trustees Act 1996 (consultation with beneficiaries) shall not apply
