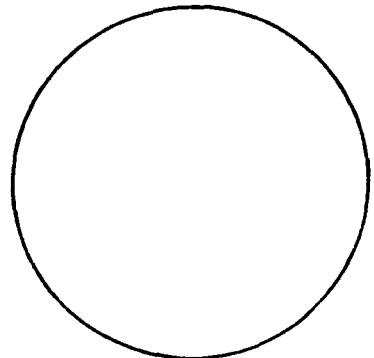

I WILLIAM CALVERT of 40 Beaver Road in the City of Carlisle hereby revoke all former Wills and testamentary dispositions made by me and declare this to be my last Will which I make this 2nd day of July One Thousand Nine Hundred and Ninety.

I GIVE DEVISE AND BEQUEATH all my Estate both real and personal whatsoever and wheresoever unto my wife Mabel Marjorie Calvert absolutely and I APPOINT my said wife to be sole Executrix of my Will PROVIDED NEVERTHELESS that if my said wife should predecease me then I APPOINT my niece Alison Jane Calvert of 50 Rosebery Road Carlisle and my wife's nephew Kenneth Irving Gash of North ^{End} Cottage ^{BE} Great Orton Carlisle to be Executors and Trustees of this my Will and in this event the following provisions shall then apply:

I GIVE DEVISE AND BEQUEATH all my Estate both real and personal whatsoever and wheresoever unto my Trustees Upon Trust to sell call in and convert the same into money with power to postpone such sale calling in and conversion so long as they shall in their absolute discretion think fit without being liable for loss.

MY TRUSTEES shall hold the net proceeds of the said sale calling in and conversion and my ready money upon the following trusts:

- (a) Upon trust to pay thereout my debts and funeral and testamentary expenses.
- (b) Upon trust to hold the residue thereof to pay the income therefrom unto my son Nigel Irving Rodney Calvert until my said son should attain the age of Fifty years.
- (c) After my said son has attained the age of Fifty years to pay the capital and income of my residuary estate to my said son

absolutely PROVIDED NEVERTHELESS that if my said son should die in my lifetime or before attaining the age of Fifty years my Trustees shall hold the residue of my estate as follows:

(i) Upon trust for such of the children of my said son Nigel Irving Rodney Calvert as shall attain the age of Twenty-one years and if more than one in equal shares.

(ii) If my said son should die in my lifetime or before attaining the age of Fifty years without children surviving then my Trustees shall hold the residue of my Estate as follows:

Road Carlisle.

My Regency Mahogany Barometer (Shell) for Kenneth Irving Gash
of North End Cottage Great Orton Carlisle.

My Oak Barometer for Michael Stuart Gash of 98 Braid Road
Morningside Edinburgh.

My Grandfather Clock for Thomas Nicholas Gash of 79 Beech Grove
Stanwix Carlisle.

All the rest residue and remainder of my Estate unto such of the
following as shall survive me and if more than one in equal shares:
The said Michael Stuart Gash, the said Kenneth Irving Gash, the

said Thomas Nicholas Gash, the said Cathérine Irving Gléncross,
the said Alison Jane Calvert and Stéwart David Calvert of 91 Gosling
Drive Moorville Carlisle.
